

Welcome to your first step on the ladder to becoming a professional LGV operator, from local to European wide driving, from delivering groceries to self-loading 20-ton machines there is a job out there to suit everyone with a professional driving qualification.

Before we at the Monex Academy can get you behind the wheel of a truck to assess your training requirements you will need to obtain a provisional licence, please refer to the following section of the Government website which will provide all the information you require.

To obtain a provisional licence you will need to:

- Be 18 years of age or over
- Or you can follow these simple steps:
- Hold a UK driving licence for a car
- Obtain a "medical examination report" from your GP or a vocational medical examiner and have them complete form "D4"

this must be returned to the DVLA with form "D2"

As soon as you have received your coveted provisional licence in the post, which will take approximately three weeks, please contact us at <u>academy@mcluk.com</u> and arrange to come in for a free 30 minute assessment that can be booked around your current work commitments, during your assessment we can talk to you about the next steps which are as follows. (Don't forget to bring your provisional licence with you, we will need to view and copy it.)

At the end of your driving assessment your instructor will be able to confirm the amount of time and therefore cost that will be incurred to train you up ready to attempt your Driver CPC part 3 test: driving ability (driving test)

NP19 4SZ Tel: 01633 293777 Email: <u>academy@mcluk.com</u> There are currently three tests that need to be passed to obtain your C category lorry licence or Driver CPC (certificate of professional competence) qualification which will permit you to drive C category or Rigid vehicles only, and once this qualification has been obtained a further two tests to obtain your full C+E (old fashioned HGV class 1) licence.

To obtain a class C licence, we will need to book the following tests :

- 1) Driver CPC Part 1 test; Theory
- (Module 1)
- 2) Driver CPC Part 2 test: Case Studies
- (Hazard perception)
- 3) Driver CPC part 3 test: driving ability

(Driving test)

Our training team will be able to assist with everything that is required for you to pass these tests all we will need from you is:

- UK driving licence number
- Email address as you will need to book by phone, if you do not have one, if you are joining an academy course the confirmation email can be sent to a member of our team
- Credit or debit card number, again we can deal with this as part of your overall package

So you've passed your category C licence and you want to move on to the big toys, C+E the articulated vehicles, the next steps are far easier now you have your Driver CPC all that's left is:

- Another Driver CPC part 3 test: Driving ability (driving test in the Artic)
- Driver CPC part 4 test: Practical demonstration

And that's it you've made it, phew.....

Over the next 12 months you will be working within one of the Monex Group divisions as a HGV driver at a reduced hourly wage to repay your training costs to the academy. This balance can be repaid early if you wanted to make an early settlement payment, the balance will be communicated to you monthly so you know where you stand.
